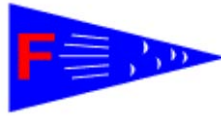

## NOTICE OF RACE

### 1 RULES

The regatta will be governed by the rules as defined in *The Racing Rules of Sailing (RRS) 2009-2012*

### 2 ELIGIBILITY AND ENTRY

- 2.1 Two seminars will be held at South Coast Corinthian Yacht Club on October 28<sup>th</sup> (mandatory) and November 4<sup>th</sup> at 8pm.
- 2.2 Eligible boats and skippers may enter by completing the attached entry form or one available at the seminars. Entry forms are also available at [www.fairwind.org](http://www.fairwind.org) and [www.asmbyc.org](http://www.asmbyc.org)
- 2.3 An eligible skipper is one that has not skippered a boat in more than one ORCA, PHRF or two cruising races.
- 2.4 Completed entry forms will be accepted by e-mail ([race\\_chair@fairwind.org](mailto:race_chair@fairwind.org)) until 1900 hours Friday November 6, 2009.

### 3 SAILING INSTRUCTIONS

The sailing instructions will be available at the skipper's meeting on November 7<sup>th</sup>, at 9am, dock C-2400.

### 4 SCHEDULE OF RACE

- 4.1 The R/C will attempt to run up to 3 races.
- 4.2 The scheduled time of the warning signal for the first race is 1155 hours

### 5 THE COURSES

Course will be selected from the Marina del Rey Course Chart 16 (supplied at the skipper's meeting). The course will be random leg.

### 6 SCORING

No race score will be excluded. This changes **RRS A2**

### 7 HOSPITALITY

The awards ceremony will be held at South Coast Corinthian Yacht Club, 113445 Mindanao Way Marina del Rey, CA 90292, following the last race.

### 8 PRIZES

- 8.1 The first place winner of each class will have their name engraved on the **Darien Murray Memorial Trophy**.
- 8.2 Individual "take home" trophies will also be presented at that time.

## RACE ENTRY AGREEMENT

RACE ENTRY AGREEMENT with the Association of Santa Monica Bay Yacht Clubs ("ASMBYC"), South Coast Corinthian Yacht Club ("SCCYC"), and Fairwind Yacht Club ("FYC"): In consideration of your acceptance of my entry, I agree as follows: (1) My boat will be equipped to conform with any USCG safety requirements and those of any fleet or association whose rating system will be used for the race in which I compete. (2) I agree to comply with the rules of the ISAF, as adopted by US Sailing, and by all other rules and sailing instructions governing the race. (3) Any contestant or any member of the race or protest committee may inspect my boat before or after the race. (4) I hereby release ASMBYC, SCCYC, FYC, together with their officers, directors, agents, employees, volunteers, and committees from any and all liability for any injury to myself, my crew or my boat arising out of their conduct of the race or use of the facilities, provided that such release does not discharge my insurance carrier under the provisions of insurance policies on my boat. This waiver shall not be deemed as any indemnity on my part. (5) I assume any risk of injury arising out of my participation in the race, failure or breakage of my boat or any of my equipment, or weather conditions. (6) I acknowledge that the safety and seaworthiness of my boat, and the decision to race or keep racing, is my sole responsibility and ASMBYC, SCCYC, and FYC, in accepting my entry, assume no responsibility therefore. (7) I will notify the race committee promptly upon withdrawal from the race. (8) I certify that my crew and I are able to swim.
